2021 most successful business year of Exentis

- ◆ Sales CHF 20 million, EBITDA CHF 3.5 million
- ◆ First Exentis 3D system placed in the USA

Stetten, Switzerland, May 18, 2022 - EXENTIS Group AG, provider of the world's only 3D technology platform that enables industrial large-scale production, has concluded the 2021 financial year as the most successful in the company's history to date. Following today's receipt of the unrestricted audit certificate from auditing company BDO, Zurich, EXENTIS publishes key figures.

With sales in fiscal year 2021 amounting to Swiss Francs 20.02 million, the Corona year 2020 was left behind. The conclusion of licensing agreements with users of the EXENTIS technology, the EXENTIS 3D Community members, for the Australian and New Zealand markets and for the application "Industrialized Additive Manufacturing of Energy Storage" contributed significantly. Under these new and existing license agreements, the EXENTIS 3D Community members acquired four EXENTIS systems in Australia. At the end of fiscal year 2021, the first EXENTIS 3D development system was placed in the U.S. for 3D Community member Laxxon, a leader in the manufacture of 3D printed tablets with freely selectable drug delivery profiles. Another EXENTIS 3D development system for industrial application was delivered to the Fraunhofer Institute in Dresden.

The successful business activity is also reflected on the earnings side in an operating result (EBITDA) of Swiss Francs 3.54 million. This means that an operating margin (EBITDA) of 18% was generated. Total assets at the end of the fiscal year amounted to Swiss Francs 47.87 million.

EXENTIS will publish the full annual financial statements in German and English as part of the annual report on June 8, 2022 and present them to its shareholders. The Annual General Meeting will be held at the company's headquarters in Stetten near Zurich on June 30, 2022. A separate invitation will be sent out with the presentation of the annual report.
