Exentis posts double-digit growth

Stetten – Exentis increased Group revenues by +15 percent to 11.4 million Swiss francs in the first half of 2023. There was also disproportionately strong growth in the operating result, which now stands at 2.1 million Swiss francs. The provider of a leading 3D technology platform for industrialized additive manufacturing will now turn its attention to further international growth plans.

In the first half of 2023, the [Exentis Group](#) generated revenues of 11.4 million Swiss francs in the three business areas of Pharma & MedTech, New Energy and Ultra-fine Structures. This equates to year-on-year growth of +15 percent, as the company, which specializes in the area of industrialized additive manufacturing and is headquartered in Stetten in the canton of Aargau, writes in a [press release](#). Across the same period, the Group also recorded growth of +74 percent in the operating result (EBITDA), with this metric now amounting to 2.1 million Swiss francs.

For the second half of 2023, Exentis expects to accelerate growth. To this end, the Group is in the process of expanding its capacities at its German location in the vicinity of Freiburg.

The management consultancy firm Roland Berger has identified a market potential of around 200 billion Swiss francs for Exentis. In order to tap into this potential, the Group will pursue three strategic initiatives. In specific terms, Exentis plans to further internationalize its 3D technology platform, reorganize the sales function and digitize all internal and customer-related processes.

In the area of internationalization, the focus will be on the USA: “Via our subsidiary Exentis North America Inc., which was established end of July, and our American head office in Boston, Massachusetts, we will grow our footprint in the USA, the world’s largest additive manufacturing market”, comments Gereon Heinemann, Chief Executive Officer of the Exentis Group, in the press release. Customer visits served to confirm the high level of interest in the 3D technology platform on the US market. “The flexibility, cost/benefit advantages and the possibility of large-scale manufacturing of industrial parts with free choice of materials are particularly appreciated by American customers”, Heinemann adds. ce/hs
